**APPOINTMENT FOR THE INSPECTION OF TRANSPORTABLE PRESSURE EQUIPMENT – 2017**

1. For the purposes of this letter-

'CDG' means The Carriage of Dangerous Goods and Use of Transportable Pressure Equipment Regulations 2009 (as amended);

'CDGNI' means The Carriage of Dangerous Goods and Use of Transportable Pressure Equipment (Northern Ireland) Regulations 2010 (as amended);

'MSDG' means The Merchant Shipping (Dangerous Goods and Marine Pollutants) Regulations 1997

'ADR' means the European Agreement concerning the international carriage of dangerous goods by road, applicable from 1 January 2017;

'RID' means the Regulations concerning the international carriage of goods by rail, applicable from 1 January 2017;

'IMDG' means the International Maritime Dangerous Goods Code, amendment 37-14 and 38-16

2. Acting on behalf of the competent authorities of Great Britain and Northern Ireland in accordance with regulation 29 of CDG, regulation 25 of CDGNI and MSN 1852 (M), issued in accordance with MSDG, the VCA Dangerous Goods Office hereby appoints Flameskill Ltd as:

- An APPOINTED PERSON for the approval of old pressure receptacles in accordance with CDG Regulation 14 and CDGNI Regulation 10
- A NOTIFIED BODY (N<sup>o</sup>. NB 2560) for the periodic inspection of transportable pressure equipment in accordance with CDG Regulation 22 & CDGNI Regulation 18.

3. The technical scope of this appointment is defined by the UKAS Schedule of Accreditation, Issue No 002, dated 20 October 2016, specifically those parts identified by an asterisk (\*) that are relevant to transportable pressure equipment in accordance with CDG, CDGNI, RID/ADR and IMDG.
4. Appointment is subject to the terms and conditions which Flameskill Ltd has previously acknowledged and accepted.
5. This appointment commences 1 January 2017 and expires 31 December 2017 unless earlier revoked.
